INVITATION TO BID

BID # 2022-0003 Type "C" 71 Passenger School Bus

The Gulf Shores City Board of Education is now accepting sealed bids from vendors for the purchase of one new School Buses.

This bid is for a complete unit delivered to the Gulf Shores City Board of Education Office located in Gulf Shores, Alabama 36542. The bus body, chassis, and equipment must conform to all State and Federal specifications at the time of manufacture. The payment for the body and chassis will be made when the completed unit is delivered to the Gulf Shores City Board of Education and not when the chassis is delivered to the body plant.

Bids will be received by the Gulf Shores City Board of Education at its Central Office at 300 East 16th Ave, Gulf Shores, Alabama until 10:00 AM, August 1,2022 at which time they will be publicly opened and read. The results of the bid will be presented to the Board at its next scheduled meeting for action. The bids must be sent via FedEx in sealed envelope. If sent regular mail, we will not receive the bid at 300 East 16th Ave.

The outside of the sealed bid must be clearly marked "BID # 2022-0003 TYPE "C" 71 PASSENGER SCHOOL BUSES". The Gulf Shores City Board of Education reserves the right to reject any and all bids or parts of bids. Payment will be made through normal Board procedures.

I. GENERAL INFORMATION

- (A) All bidders must use our form for submitting their bid.
- (B) All bids must be sealed and marked in the lower left-hand corner "BID 2022-0003 71 PASSENGER SCHOOL BUS". Late bids will not be opened.
- (C) Bids will not include State Sales Tax, Federal Excise Taxes or any other fee.
- (D) Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If the contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file.
- (E) Use of trade names and numbers shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.
- (F) It is the responsibility of the vendor to secure a copy of the **Alabama Minimum Specifications for School Buses for 2022** from the Division of Administration and Finance/Pupil Transportation Section/Department of Education, Montgomery, Alabama 36130.

II. DISQUALIFICATION OF BIDS

Bids may be disqualified before the awarding of the contract for any of the following:

- (A) Failure to mark envelope as required.
- (B) Failure to sign the bid document.
- (C) Failure to include requested information or other details of the bid.
- (D) Excessive errors.
- (E) Failure to have an original signature on the bid form, a faxed copy is not acceptable.

III. METHOD OF AWARD

- (A) The award will be made to the lowest responsible bidder(s) meeting specifications. It is not the policy of the Gulf Shores City Board of Education to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, past service and experience are among the factors that may be considered in determining the responsible bidder.
- (B) In the event the low bidder refuses to accept the entire requirements without deviation, the bid may be awarded to the next lowest bidder.

- (C) In the event that two or more vendors bid the same amount on the same item, dealership proximity to the Gulf Shores City Board of Education will determine the vendor awarded that item.
- (D) The Gulf Shores City Board of Education reserves the right to have any chassis/body offered for bid inspected by their representative prior to the selection of that vendor.
- (E) The Gulf Shores City Board of Education reserves the right to award separate contracts for each item, each product, or any combination of products, if the Board feels it is in the best interest of the Gulf Shores City Board of Education.

IV. <u>CONTRACT PERIOD/PRICING</u>

- (A) If other State or Local Funds become available, the Board may elect to purchase additional chassis/bodies from this bid.
- (B) Bid prices should be good for 90 days. Effective date of bid will begin immediately after being awarded.
- (C) May be extended for two additional 90-day periods. The extension must have the mutual consent of the vendor and the Gulf Shores City Board of Education. All terms and prices must remain the same.
- (D Prices should include delivery to Gulf Shores, Alabama

V. QUANTITIES/ORDERS/DELIVERIES

- (A) The original Purchase Order will be placed after Board approval of the bid award for approximately: One 2022 Type "C" 71 Passenger School Buses equipped with diesel motor.
- (B) Quantities are estimates only. Actual purchases may be more or less depending on funds available.
- (C) Buses must be delivered to Gulf Shores City Board of Education within 120 days of bid award.

 The only exception to the extension of the contract date will be general strikes at the chassis/body plants and acts of God.
- (D) Before the order is placed, there will be a meeting with the successful vendor to make sure all specs are understood and clarified.
- (E) At the time the buses are delivered, the vendor(s) must supply a 4-wheel alignment data sheet for each bus.

VI. WARRANTIES/SERVICE

- (A) All warranties must be clearly stated.
- (B) Availability of service must be clearly stated along with service contract pricing. Service centers with times and days of operation must be stated. If road service is provided, it must be noted.

Requirements of Vendors for Compliance with the Alabama Immigration Law

Notice of Alabama Immigration Law Compliance Requirements for Awarded Contracts or Agreements with Gulf Shores City School System Board of Education

As a Contractor, as defined in the Act, to the GULF SHORES CITY SCHOOLS BOARD OF EDUCATION ("Board"), it is critical to your relationship (future or continuing) with the Board that you comply with the Immigration Reform and Control Act of 1986, as amended by the Immigration Act of 1990, and the Beason-Hammon Alabama Taxpayer and Citizen Protection Act and as further amended by Act No. 2012-491.

Every contract or agreement entered into by the Board as a result of a competitive bid process from this point forward with a contractor will contain the following clause or one substantially similar:

Alabama Immigration Law Compliance Contract: Contractor agrees that it will fully comply with the Immigration Reform and Control Act of 1986, as amended by the Immigration Act of 1990, and the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, which makes it unlawful for an employer in Alabama to knowingly hire or continue to employ an alien who is or has become unauthorized with respect to such employment or to fail to comply with the I-9 requirements or fails to use E-Verify to verify the eligibility to legally work in the United States for all of its new hires who are employed to work in the State of Alabama. By signing this conract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

Contractor shall enroll in the E-Verify Program prior to performing any work, or continuing to perform any ongoing work, and shall remain enrolled throughout the entire course of its performance hereunder, and shall submit to the Board a copy of the e-Verify Memorandum of Understanding and such other documentation as the Board may require to confirm Contractor's enrollment in the E-Verify Program. Contractor agrees not to knowingly allow any of its subcontractors, or any other party with whom it has a contract, to employ in the State of Alabama any illegal or undocumented aliens to perform any work in connection with the Project, and shall include in all of its contracts a provision substantially similar to this paragraph. If Contractor violates any term of this provision, this Agreement will be subject to immediate termination by the Board. To the fullest extent permitted by law, Contractor shall defend, indemnify and hold harmless the Board from any and all losses, consequential damages, expenses (including, but not limited to, attorneys' fees), claims, suits, liabilities, fines, penalties, and any other costs arising out of or in any way related to Contractor's failure to fulfill its obligations contained in this paragraph.

To the extent that there is no formal written contract between the Board and the Contractor, such as where business is conducted by purchase order, this document shall serve as the Alabama Immigration Compliance Contract.

I Intent to Bid

The intent of this bid is to establish a contract between the Board and bidder for the furnishing of school bus (es) described herein. It is estimated that one school bus will be needed, but the right to purchase additional school buses in addition to the stated quantity at the bid price is reserved by the Gulf Shores City Board of Education.

II Qualifications of Bidders

Any person, firm, or corporation submitting a bid must be the manufacturer's authorized sales and service agent for the items quoted. Bids will be accepted only from firms engaged on a full time basis as a school bus supplier.

Bids will be accepted only from vendors who are the manufacturer's authorized sales and service agent for the product offered, who are authorized and qualified to conduct business in Alabama, and whose existing factory authorized sales and service area of responsibility includes Gulf Shores, Alabama. Each specification requires a complete response, not simply a "manufacturer's standard."

III Requirements of Bidders

- A. All bidders must complete the listed specifications. Each line requires a response stating the specifications proposed by the bidder. In the event that the specifications proposed by the bidder are exactly and unequivocally identical to the specifications established by the Gulf Shores City Board of Education, including brand name, the bidder may respond with the phrase "NO EXCEPTIONS". In all other cases, and for all brand name items, the bidder is required to provide written specifications. Failure to provide all information requested will absolutely disqualify a bidder from consideration.
- B. Bidder must enclose with bid submittal copies of basic and optional extended warranty documents that fully detail warranty coverage provided. All warranties must be those offered by the original equipment manufacturer(s) only.
- C. Before delivery, each bus must have been inspected by the appropriate State Department of Education inspector and been properly approved for road use.
- D. Successful bidder will be responsible for any and all damages prior to receiving.
- E. All prices submitted on this proposal are to be delivered prices to the board office at 300 East 16th Ave., Gulf Shores, Alabama.
- F. Bid prices should not include sales tax. Tax exemption certificates
- G. Successful bidder shall contact the Board of Education office to schedule delivery of each bus.
- H. Vendor shall provide upon delivery one complete set of the most current service and parts manuals, to include both body and chasis at no additional cost. Electronic documentation is acceptable.
- I. Vendor shall be responsible for towing if a bus has to be towed due to a warranty issue.

IV Method of Award

- A. The method of award will be based on the bidder that has the lowest unit base price plus any and all options as selected by the Board of Education. The Board of Education reserves the right to reject any and all bids.
- B. The Board of Education may not award on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, terms of payment, dates of delivery, past service, and experience are among the factors that may be considered in determining the responsive/responsible bidder.
- C. In the event the low bidder refuses to accept the entire requirements without deviation, their bid will then be considered non-responsive. After refusal by the first bidder, the bid may be awarded to the next lowest bidder.

V Proposal Form and Information Required at Bid Opening

- A. The proposal form which accompanies this bid request must be filled out legibly and in full. Failure to provide all information requested will absolutely disqualify a bidder from consideration.
- B. Costs are not to exceed two (2) decimal places.

VI Terms of Payment

- A. It is the intent of the Board of Education to pay all invoices within thirty (30) days of receipt. Should a dispute result regarding quality, terms etc., the thirty (30) days would appear after the matter has been cleared. Payment may be expedited by providing original invoices.
- B. The above stated terms of payment are the only terms which the Board will consider. Any bid which does not comply with our stated terms will not be considered for award.

Bids will be accepted only from vendors who are the manufacturers' authorized sales and service agent for the product offered, who are authorized and qualified to conduct business in Alabama, and whose existing factory authorized sales and service area of responsibility includes Gulf Shores, Alabama. The authorized sales and service facility shall not be more than three hundred (300) miles from Gulf Shores City Board of Education shop facility. Each specification requires a complete response, not simply a "manufacturer's standard."

Quantity: 1 or more. Delivery of bus(es) desired within 120 days of purchase order receipt.

BUS CHASSIS Specifications

- 1. Engine and Transmission: The engine shall be Cummins B 6.7, electronic diesel. Cylinder configuration shall be in-line six. The engine shall produce not less than 250 HP and 660 lb.-ft. of torque at rated RPM and will include engine exhaust brake with variable vane turbocharger. The engine shall meet all current emission standards. The bus shall be provided with an engine alarm system that includes both visual and audible alarms notifying the driver in the event of low oil pressure or high-water temperature. The transmission shall be Allison 2500 Series, 5-speed with overdrive. Synthetic transmission oil shall be provided. NO EXCEPTION
- 2. Warranty: Quote as option (1) extended Cummins engine warranty to 10 year / 100,000 mile covering all engine components, engine electronics (2) Towing to an authorized warranty center for engine or chassis related occurrence extended to 2 years unlimited miles. The electronic transmission shall be warranted for at 7 years without mileage limitation. Extended warranty costs will be separate line items on bid proposal form and will not determine low bidder. 30. Seat and barrier material shall be fire retardant type. Seat upholstery shall have a two-year warranty. Seat foam shall have a 4-year warranty. Seat configuration on street side: (11) 39" high back seats and (1) 26" high back seat. Seat configuration on curb side: (12) 39" high back seats. For increased comfort, the driver's seat shall be a six-way adjustable high back design and shall be equipped with a threepoint shoulder harness, a right-hand arm rest, cloth insert and adjustable lumbar support. Seat shall be air suspension type.

- 35. The bus shall be air-conditioned. Total system BTU shall be 126,000 and consist of the following components:
 - Compressors: Dual.
 - Condensers: OEM standard to produce 126,000 BTU required
 - Evaporators: One (1) front bulkhead in-wall, one (1) rear bulkhead in-wall and one (1) dash unit shall be rated at approximately 26,000 BTU cooling and 35,000 BTU heat. It shall have two (2) dash mounted air vents and one (1) step well vent. Flush mounted ABS front and rear covers shall be provided with four (4) air vents and two (2) front-mount filters for easy service.

The air conditioning system is controlled by rocker type switches located on the driver's switch panel. Separate switches shall control on/off function and speed (high/medium/low) for the front, rear, and dash mounted evaporators.
